Urban Heat Island Mapping Project – Community Volunteer Event

As previously reported in the *Manager's Update* (Issue 2021-15), Raleigh has joined the National Oceanographic and Atmospheric Association (NOAA), the County of Durham, the NC Climate Office, NC Museum of Life and Science, NC Museum of Natural Sciences, Activate Good, and others to map the hottest parts of the city as part of the <u>Urban Heat Island Mapping project</u>. This project supports climate action in the <u>Community Climate Action Plan</u> as well as two initiatives in the City's <u>Strategic Plan</u>: one focused on mitigating urban heat islands (GNR 3.4), and another on environmental justice mapping (GNR 3.1). Participation in this project will help Raleigh identify areas where heat is experienced most strongly by our community members.

Two project partners - the National Weather Service and the State Climate Office of NC - have been monitoring the weather forecast trends this summer to project hot, dry days without rain, which are requirements for the volunteer mapping project event. This summer, the weather has been wetter than anticipated and the forecasting has been challenging. Just this week staff finally received word that Friday, July 23 satisfied the weather requirements. With support from Activate Good, staff quickly assembled volunteers to participate. Volunteers either placed heat sensors on their vehicles (cars or bikes) or walked while carrying the sensor on their phone. Volunteers were sent along set routes in the morning, afternoon, and the evening along set routes to record temperature, humidity, time, and the sensor locations. The collected data will be used to create a map of Raleigh's heat islands. The volunteers started

from Chavis Park and Kiwanis Park at 6 a.m., 3 p.m., and 7 p.m. The routes were spread across the city and take into account different land uses, tree cover, community landmarks, and vulnerable community locations.





NOAA's National Integrated Heat Health Information System (NIHHIS) and partners are launching new campaigns that will map the hottest parts of cities in 11 states across the country this summer, including Albuquerque, Atlanta, New York City, Charleston, Kansas City, Missouri, San Diego, San Francisco, as well as parts of New Jersey, Indiana, Massachusetts, and Virginia. This project will raise awareness about heat risk, incorporate local perspectives to produce heat maps, and engage communities in pursuing solutions.

Subject	Council Response – Concerns Stemming from 4813 Mimetree Court

This memo responds to an inquiry by Council Member Cox concerning allegations of trespassing and dangerous canines at 4813 Mimetree Court.

Ms. Lisa Spears, the resident at 4808 Mimetree Court, reported to Council Member Cox that her neighbor residing at 4813 Mimetree Court allows her children to trespass on the complainant's property and has repeatedly allowed three canines to run at-large in the community.

A review of police department calls for service for Mimetree Court, between July 1, 2020 and July 15, 2021 revealed three calls from Ms. Spears and three calls from another resident concerning stray dogs in the area. Additionally, three calls were received from Ms. Spears concerning the ongoing problems with her neighbor at 4813 Mimetree Court.

Raleigh Animal Control Officers have responded to 4813 Mimetree Court on previous occasions and found no violations during those visits. Reports of the animals running at-large in the community were addressed, however, during each visit to the residence Animal Control Officers observed the canines on the property and not running at-large. The canines have been found to be friendly and well cared for during past visits.

Animal Control Officers again visited the residence at 4813 Mimetree Court on July 6, 2021. During this visit, the three canines were found to be friendly, in good condition, and having food and water available. Vaccination records for two of the canines could not be located and a citation was issued for Amanda Nicole Niemic for two counts of failing to provide proof of rabies vaccine for these canines.

Animal Control Officers conducted an examination of the fence around the rear of the residence and found that work is ongoing to mitigate the potential for the canines to breach the top and escape into the community.

Northeast District Community Officers have contacted Ms. Spears and are reviewing video footage of past encounters with her neighbor and the canines. Any footage depicting Ms. Niemic's children trespassing on her property or criminal activity will be identified and a follow-up investigation will take place. Raleigh Animal Control Officers will continue to monitor this situation for potential violations involving the canines residing within the residence. Community Officers from the Northeast District will continue to be the point of contact for Ms. Spears regarding any additional concerns about her neighbor.

Subject	Council Response – Hill Street Pedestrian Crashes

This memo responds to a request for information on motor vehicle versus pedestrian crashes in the 000-500 blocks of Hill Street.

During the public comment portion of the July 6, 2021 Council Meeting, Ms. Octavia Rainey remarked on the 25 MPH signs recently posted on Hill Street and on surrounding streets. Furthermore, she reported 15 motor vehicle versus pedestrian crashes involving young African American male and female pedestrians on Hill Street, between 1978 and 2010. This accounting was based on data from records maintained by Ms. Rainey.

Hill Street begins in the 000-block at New Bern Avenue and extends north past Boyer Street, E. Jones Street, Pender Street, E. Lane Street, Oakwood Avenue and Booker Drive. The street terminates in its 500-block where it merges with Milburnie Road. Raleigh's Traffic Schedule No. 5 *Speed Limits* shows that the speed limit on Hill Street between New Bern Avenue and Oakwood Avenue was reduced to 25 MPH on January 26, 2021. Previously, the posted speed limit on Hill Street was 35 MPH.

A review of motor vehicle versus pedestrian crashes in the 000-500 blocks of Hill Street was undertaken. An examination of police department records between 1999 and 2021 revealed three crash reports involving pedestrians occurring on Hill Street. One of these reports was obtained from the police department's records management system (P17009656) and, because of the years of the reports, two were requested from the NC Division of Motor Vehicles (P03089508 and P07133444). P03089508 took place on Hill Street between Jones Street and Boyer Street, P07133444 took place on Hill Street between Oakwood Avenue and Booker Drive, and P17009656 took place on Hill Street between New Bern Avenue and Boyer Street.

The three crash reports involved pedestrians between the ages of 32 and 69 being struck by vehicles. All reports document the vehicles traveling between 5 and 15 MPH at the time of the crash and no significant injuries to the pedestrians are recorded in the reports. Two of the reports indicate that the drivers directly contributed to the collisions and the third report has contributing factors for both the motorist and pedestrian. One of the drivers was cited for a safe movement violation as a result of the crash.
