Downtown Weekend Street Closures for Signage Installation

As part of the 301 Hillsborough Street office project, signage contractors will conduct a full closure of Hillsborough Street between N. Dawson Street and N. Harrington Street, and a significant partial closure of Dawson Street at Hillsborough Street, beginning 6 p.m. on Friday, Oct. 22 thru 6 a.m. on Monday, October 25 for crane setup and signage installation. Dawson Street will be restricted to a single lane during the same time period. Traffic message boards will be in place to assist drivers with early notification before approaching this area.

Motorists are encouraged to seek alternate routes and exercise caution in the work and detour zones.

This is the second attempt to complete the signage installation. The first closure was scheduled the weekend of Oct. 8 but cancelled due to inclement weather. This schedule is also subject to change pending weather or other unforeseen conditions.

Detour around work area:

• Motorists traveling westbound on Hillsborough Street will take a left on S. Dawson Street and then a right onto W. Morgan Street.

 Motorists traveling eastbound on Hillsborough Street will take a right on S. Harrington Street and then a left on W. Morgan Street.

Farmer's Market Pilot Program

In April 2021, City Council approved the recommendation by the Economic Development and Innovation Committee that included direction to the Parks, Recreation and Cultural Resources Department (PRCR) to create a pilot Farmer's Market program:

"The Committee also recommends that Council direct staff to develop the next steps for a pilot program using City parks for neighborhood healthy food access with farmers' markets. Before developing a pilot program, staff from Parks and Recreation must:

- Work with the City Attorney's Office and Risk Management on liability question
- Identify where to host the markets
- Establish the agreement tool
- Identify the partner(s)

It is also understood the pilot program would begin in Fall 2021 at one park location; however, staff is encouraged to explore the possibility of having the farmers' market pilot program at 2 park/community center locations."

With guidance provided by City Council, staff created an internal team to research procedures and protocols to meet the fall target. This included connecting with other municipalities, learning from departments across the country and connecting with staff that operate the market at Moore Square (delivered in partnership with DRA). As summer progressed, dedicating resources to the research and development of the pilot program became increasingly difficult. As the pandemic persisted with the increased impact attributed to the delta variant, PRCR experienced significant difficulty in its ability to recruit and retain personnel needed to sustain summer operations. Additionally, PRCR learned that they were not alone in the struggle to deliver programs and services due to limited resources as many potential partners were unable to dedicate resources to this proposed pilot program. Regrettably, staff will not be able to meet the goal of a fall 2021 implementation.

Recognizing that the need for healthy food options is a primary component to community health, PRCR is working on an interim step as energy is refocused to deliver the markets in the spring of 2022. Staff are engaged with a local delivery service, Produce Project (https://www.produceproject.org/) where extra food is donated to local non-profit organizations that serve the community. Staff will investigate options to deliver this program out of the community center at John Chavis Memorial Park and to use the Produce Project as a bridge to get to the next step of a pilot farmer's market program.


Follow Up from the September 14 Work Session

Scooter Parking Corrals - Glenwood South

During the work session several issues in the Glenwood South Hospitality District were discussed, including scooter user behavior in the Glenwood Avenue corridor. Transportation staff has worked with internal stakeholders, the Downtown Raleigh Alliance, and the Glenwood South Neighborhood Collaborative to pilot a total of 13 parking corrals for dockless scooters in the Glenwood South area.

Eight corrals will be installed on Glenwood Avenue, two on West Johnson Street, one located on Tucker Street, and two on West North Street. The planned corrals will be incorporated in curb space that is already zoned "no parking." Fire hydrant, line of sight, and corner clearances will constitute the space that will absorb the dedicated scooter parking. A private parking deck entrance that is no longer in use will also be used for this new infrastructure. The image below provides an overview of the pilot locations:

Staff is coordinating with the authorized scooter companies (Bolt, Lime, and Spin) to use these locations as drop-off zones and is enhancing geofence technology that will enforce scooter users to park in these locations between the 00 and 600 blocks of Glenwood South. Geofencing uses GPS to create a virtual perimeter or boundary that can trigger a programmed reaction within the scooter, like to slow down or to park in certain areas.

Staff and the scooter companies have collaborated on procedures to mitigate scooter-related issues on Glenwood South. These changes include:

- The creation of 339 feet of dedicated scooter parking on and around the Glenwood South area. Glenwood Avenue will gain a total of 221 linear feet of scooter parking, while 118 linear feet of scooter parking will be installed on Tucker, Johnson, and North Streets.
- No scooter parking on Glenwood South is permitted between Peace and Hillsborough Street, except for designated scooter parking corrals.
- Scooter companies will only deploy in designated scooter parking corrals on Glenwood South between Peace Street and Hillsborough Street.
- Available space in each corral will be divided into 12-foot parking zones. For fairness
 amongst the three companies, each company may deploy 3 vehicles per 12-foot zone.
 Outside of Glenwood Avenue, each company should still deploy 3 vehicles per block face.
- Parking will be enforced through geofence technology, showing Glenwood as a "no park zone" except for designated locations. Scooter users who ignore the "no park zone" will be charged by the operator until their trip is ended in a permitted space.
- Scooter companies will incentivize users to end trips correctly with the creation of "reward zones." (Reward zones will coincide with the proposed parking corrals.) Incentives will differ based on the company but could include discounted or free rides.
- Between Peace Street, Boylan Avenue, Hillsborough Street, and West Street, speed will be reduced from 20 mph to 10 mph on Friday, Saturday, and Sunday from 7:00 PM - 4:00 AM.
- Each company will deliver monthly reports to staff that include heat maps and data on how many trips have started and ended in each location. Staff will evaluate data on a monthly basis to monitor progress along the corridor.

Glenwood Avenue stakeholders were notified of these changes two weeks prior to installation through a letter from staff and an enclosed map of the new scooter parking locations. Staff has added messaging to the City of Raleigh Dockless Scooter page and pushed information out through social media platforms to inform users and stakeholders of these upcoming changes. Scooter companies have communicated these changes to their users via email and in-app messaging platforms.

Staff will continuously monitor behavior and progress on the Glenwood South corridor over the next several months and make changes to the program as necessary. If successful, expansion to Fayetteville Street, Hillsborough Street, and other popular destinations is likely.
