Greenway Partial Closure - Lake Lynn Loop Trail

The Lake Lynn Loop Trail will be closed along the east side of Lake Lynn beginning May 1 through November 1, due to a trail renovation project. Trail improvements include grading, drainage, repaving and widening of

the trail from 8' to 10'. These improvements will help address trail asphalt damage due to tree roots, aged asphalt and will also improve user conflicts associated with inadequate pavement width.

The west side of the Lake Lynn Loop Trail will be open during construction, however, access around the entire lake will not be available. The properties adjacent to the east side of Lake Lynn will not have direct access to the greenway trail during this time and have been advised to use parking lots located at Lake Lynn Community Center, 7921 Ray Road, and the main Lake Lynn Loop access point located at 3210 Lynn Road. This project is supported by 2014 Parks Bond funding.

2022 Traffic Calming Projects - Initial Balloting Results

The Neighborhood Traffic Management Program (NTMP) was created to identify neighborhood streets with speed compliance issues and to work with the neighborhoods in those areas to generate and implement traffic calming solutions unique to the need of an individual street. Traffic calming projects in Raleigh are not a mandate, but rather implemented through neighborhood approval, gauged by a balloting process.

As traffic calming projects impact those along the street and in the greater neighborhood differently, all ballots are administered using a two-tiered approach. Residents that physically live along the eligible street (on-street) are the most impacted and balloted separately from residents that live in a two-block radius (neighborhood) surrounding the eligible street. The on-street approval rating must meet or exceed a minimum of 70% of the participating residents for the project to be deemed successful. The neighborhood approval rating must meet or exceed a minimum of 60% of the participating residents for the project to be deemed successful. In circumstances where there is a split decision between the on-street residents and the neighborhood residents, a great emphasis is put on the on-street residents as they have greater impacts. In this case the NTMP policy specifies if a minimum of 50% of all the on-street residents participate in the balloting and meet the minimum approval rating, their approval of the project takes priority.

The table below provides the results from initial balloting for the 2022 traffic calming projects. Common Oaks and Navaho Drive – West did not meet the minimum thresholds to proceed in the process. Please note that the entirety of Navaho Drive – West is currently going through the rezoning process which may have resulted in the 0% on-street & neighborhood approval rating.

White Oak Road – North resulted in a split decision ballot between the on-street and neighborhood approval ratings and met the minimum threshold to continue moving forward in the process.

18 of 20 streets met or exceeded the policy warrants to move forward into the project design and neighborhood comment period of the process. Over the next few months, staff will begin the traffic calming design phase for each individual street. Designs will be refined based on the unique characteristics as well as input from residents. Once designs are complete, the balloting process will occur one final time prior to construction; staff will provide an update to Council at that time.


