

Street Closure STC-13-2021: Portion of Seaboard Avenue

Seaboard II LLC is petitioning the City to close approximately 2,651 SF of Seaboard Avenue right-of-way, located on the north side of Seaboard Avenue to the east of Semart Drive. A site plan is under review on the adjacent parcel (ASR-0033-2021) for the development of a 7-story, mixed-use building with 204 residential units. The street closure will be a condition of approval of the site plan.

Staff will be recommending on the May 3 consent agenda that a public hearing on the closure be authorized for June 7. Staff notes that there is no direct or substantial indirect relationship between the referenced street closure and the pending rezoning case on adjacent property located at 707 Semart Drive (Rezoning Z-5-2022).

Council Member Follow Up Items

Follow Up from the February 15 City Council Meeting

<u>Graffiti Removal along the Rail Corridor in Glenwood South (Mayor Baldwin)</u> Staff Resource: Michael Moore, RDOT, 996-3030, michael.moore@raleighnc.gov

Following public comment at the February 15 City Council meeting, Council requested that staff investigate and potentially remove graffiti from structures adjacent to the existing CSX railroad corridor along Glenwood South. This request was made in conjunction with a request for an update on the installation of waste receptacles in the district; that information was provided in *Manager's Update Issue 2022-09* (March 4).

Graffiti removal along railroad corridors is typically time extensive and requires considerable coordination with railroad operations due to safety concerns. It is also typically very expensive; the railroads dictate the terms of access and require flagging operations and other safety measures to protect workers while simultaneously maintaining regular rail operations. Fortunately, the City was able to avoid much of this time and expense by aligning the request to address graffiti adjacent to tracks by accessing the corridor to coincide with scheduled CSX rail crossing repairs at West Harrington, N. West, and West Jones streets last weekend, April 16. Staff with the Transportation Department successfully removed graffiti from multiple areas and structures located within the CSX right-of-way, at minimal additional cost to the City.

Follow Up from the April 5 City Council Meeting

Boat Storage at Lake Wheeler: Abandoned Boats (Council Member Forte)

During the meeting Council requested staff to follow up on reports of abandoned boats at Lake Wheeler Park and to attempt to determine ownership and dispose of any such vessels via the appropriate surplus/abandoned property means.

Staff has reviewed current year (2022) records for all boats stored at Lake Wheeler Park. At this time all boat storage spaces are paid in full; no boats are presently being stored that have not paid the required annual fees. Boat storage is assessed annually and when storage fees become past due, the owner is contacted to either make payment or remove the boat. Following such notice, if an owner remains non-responsive, staff has in the past utilized the authorized process to have the boat removed and disposed of as abandoned property.
