Boards and Commissions have played an important role for many years in helping to provide input from residents to assist Council with decision making. Unfortunately, without much oversight, the Boards and Commissions have operated independently of one another without much consistency in approach, management, and communication.



<u>Issues</u>: Without clear guidance, Boards and Commissions communicate differently from one another, using different channels, styles, and brands. In some cases, a Board and Commission will take public positions that are in direct opposition of City Council, while using the City's logo which can create confusion for the community. Such disparity leads to confusion from our community and a lack of unified approach to communications.

<u>Challenges</u>: How can City staff support the communications needs of our Boards and Commissions in a way that provides them the tools they need to be effective, without creating opportunity for additional confusion with official communications from City departments or City Council? Additionally, not all Boards and Commissions are the same - some have statutory requirements and depending on the subject matter, may overlap with City policy and activity. Examples include the Planning Commission, Appearance Commission, RHDC, RHDC COA, Civil Service and the Board of Adjustment. It is the desire of staff to provide solutions that recognize the difference between Board and Commission opinion vs. official bylaw or annual work plan; provides consistency across all advisory boards; accommodates limited staff support; and provides clear, easy to use experience for our residents.

<u>Recommendations</u>: The Communications Department in partnership with the Office of Community Engagement recognize that with the increased growth of boards, commissions, and committees there is a need for leadership, consistency, and clarity around support for these bodies. As such, staff is recommending:

- The Office of Community Engagement provide leadership to Board and Commission liaisons to provide guidance on best practice, support services, and unified approach.
- Communications develops series of communications templates (fliers, postcards, posters, brochures, email/ SMS templates, etc.) that have a similar "look and feel" to our City of Raleigh corporate brand without the official City logo. (see below for examples)



- Communications and Office of Community Engagement work with Board and Commission liaisons to train them on how to utilize the new templated communication tools and help empower Board and Commissions to produce their own communication needs.
- Liaisons can work with Communications and Office of Community Engagement to promote larger Board and Commission initiatives through the City's official website and social media channels.

• Statutory Boards and Commissions (listed above) will have access to City logo due to the nature of their workplan.

 Should a Board and Commission choose to create their own press release or social media channel, independent of the City, we recommend they include a disclaimer acknowledging the views and opinions do not necessarily represent the City of Raleigh.

# **Boards and Commissions Dashboard Update**

The initial phase of the Boards and Commissions Dashboard will be launched for public release on the City website. The City Clerk's Office will be sending the link for Council to test and provide feedback. Communications will develop a communications plan to inform and educate public in advance about this important new tool. Additionally, the City Manager's Office is working closely with the City Clerk, Information Technology and Communications to identify an additional tool to work in conjunction with the dashboard to include management of applications, nominations, and electronic balloting. More information about implementation should be available in the coming weeks.

# Council Member Follow Up Items

Follow Up Item from the March 1 City Council Meeting

<u>Coxindale Drive - Traffic Calming Eligibility - Rezoning TCZ-58-2021 (Council Member Buffkin)</u> Staff Resource: Will Shumaker, Transportation, 996-4175, <u>William.shumaker@raleighnc.gov</u>

During the meeting Council requested staff provide an update on the status and history of traffic calming for Coxindale Drive, between Woodstone Drive and Litchford Road, in relation to the rezoning request TCZ-58-2021.

Coxindale Drive has been evaluated twice previously based on resident request. Both evaluations failed to identify a speed compliance issue and meet the minimum scoring criteria for a future traffic calming project. The first evaluation was performed in 2005 and had an 85<sup>th</sup> percentile speed of 35.39 mph in a 35-mph zone. The second evaluation was performed in 2013 and had an 85<sup>th</sup> percentile speed of 36 mph in a 35-mph zone. No traffic calming requests have been made by the neighborhood to city staff since the last evaluation in 2013.

In 2016, residents along Coxindale Drive reached out to city staff and requested a speed limit reduction. At that time, the process required a resident circulated petition with a minimum of 75% of the properties along the street signing the petition in favor of the reduction. 86.4% of the properties along Coxindale Drive signed the petition in support of the speed limit reduction, surpassing the minimum level of neighborhood support. The speed limit reduction was presented to Council and codified in 2016, reducing the speed limit to a posted 25 mph.

With the rezoning case TCZ-58-2021, some in the neighborhood voiced a renewed interest in a traffic calming project. Staff re-evaluated Coxindale Drive and found that the minimum warrants for a future project were met. A traffic calming evaluation was completed on April 26, 2022, which found an 85<sup>th</sup> percentile speed of 32.24 mph in the 25-mph zone. There have been zero speed related crashes along Coxindale Drive in the previous 3 years. To qualify for a future traffic calming project, the 85<sup>th</sup> percentile speed of a street must be a minimum of 5 mph over the posted speed limit. The evaluation identified an approximate speed compliance issue of 7 mph for Coxindale Drive.

Traffic calming projects in Raleigh are offered using a worst first approach. Staff evaluates each individual street, identifies the severity of the speed compliance issues, checks for any speed related crashes, and looks at street specific details such as curves, hills, and pedestrian generators (i.e., parks, sidewalks, commercial properties, etc.). The evaluation data is then viewed through a scoring matrix to help quantify the severity of the issues identified. Streets are rank by overall score with the streets with the greatest quantifiable need receiving the opportunity for a project first. Coxindale Drive ranks 77 out of 99 currently qualifying streets. Based on staff's current output of 20 traffic calming project offerings each year, it could be approximately 4 years before a project is offered to the residents along the street. The traffic calming project list is dynamic just like traffic patterns and new streets can be added, removed, and/or relocated on the priority list based on updated evaluations. This dynamic nature of the traffic calming project list may impact the project offering timeline.
