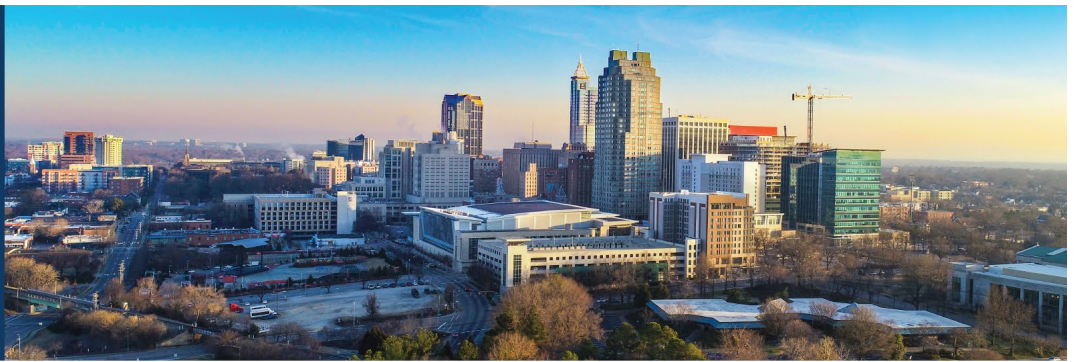

On March 25, 2022, staff from Planning and Development as well as the Transportation departments met for the first what is now quarterly, peer-to-peer planning coordination meetings between Raleigh and Knightdale planning and transportation staff.

The second meeting was held on July 15; items discussed in each meeting pertain to current and future land use; development; and transportation issues at the Raleigh/Knightdale border that require coordination from each municipality in an effort to ensure better outcomes. Specifically, the following topics were discussed:

- The Buffalo Road Corridor
- TCZ-91-21
- ZMA-9-21 (Buffalo Road Rivertowne/Brio)
- Hodge Road Development Update (Z-16-20)

- Update on Knightdale CTP Draft Recommendations

The next meeting is scheduled for November 4, 2022. Planning and Development staff will continue to provide periodic updates to Council regarding this collaboration.

Subject	Council Response – Moore Square Incident Update

This memorandum updates Mayor Baldwin on an incident occurring in Moore Square on June 12, 2022.

Ms. Stephanie Martinez addressed Council at the July 5, 2022, evening session. She provided details of an assault incident occurring within Moore Square Park on June 12, 2022. During the explanation, she added that persons regularly visiting Moore Square Park report rising criminal activity. This activity includes homeless persons being harassed and having their property stolen while sleeping in the park.

Ms. Martinez visits Moore Square Park to conduct street ministry to homeless and elderly persons who frequent the area. She is currently in the process of becoming an ordained minister. During the afternoon of June 12, 2022, Ms. Martinez was in Moore Square Park when a group of juvenile females began arguing with one of her friends. Ms. Martinez attempted to intervene and was assaulted by one of the juveniles who fled the park after the incident. The assault involved the juvenile punching her on the shoulder and rocking her wheelchair. Ms. Martinez was not injured during the incident and did not recognize the suspects. This report is the first occasion Ms. Martinez was the victim of an assault in Raleigh.

This incident was reported to a Police Officer working in the area, and an incident report was completed (P22031674). The officer attempted to locate the suspects; however, his search yielded negative results. Video footage from surveillance cameras in the area was reviewed but did not capture the incident or suspects.

A follow-up conversation was conducted with Ms. Martinez on July 12, 2022, in which she related that she had not seen the juvenile suspects again. She also said that should they be identified, she does not want them prosecuted for the incident. She's worried about an arrest ruining their lives.

Officers assigned to the Moore Square area are familiar with Ms. Martinez's incident. They will continue to focus on identifying persons negatively affecting the quality of life or committing crimes in or near the park. Police Department ACORNS personnel are continuing to work with Downtown District officers to address the needs of the homeless population who regularly visit the Moore Square area.
