# **INFORMATION:**

#### Wake County 2024 Property Tax Revaluation Process

Earlier this week the Wake County Commissioners received an update on the Wake County property tax revaluation process which will take effect for calendar year 2024. North Carolina State Statute requires real property to be revalued every eight years, Wake County elects to undergo this process every four years. The last revaluation was conducted in 2020 and as noted by Marcus Kinrade (Wake County Tax Administrator) during a recent Board of County Commissioner meeting, "Wake County's real estate market has changed significantly since 2020."

#### **Revaluation Process:**

A revaluation process is designed to ensure the assessed value of every residential and commercial property in the County reflects fair market value. The revaluation process adjusts each property's assessed value to reflect the most probable price that a property would sell for in a competitive and open market. If a

revaluation did not occur, some property owners would pay more than their share of property tax while others would pay less.

The Wake County Board of Commissioners will hold a public hearing on October 2, 2023, associated with the Schedule of Values (SOV). The SOV sets the parameters for the process and at a high level describes the methodology and procedures for the revaluation and defines property values to be utilized until the next revaluation occurs.

#### **Property Tax Rate and Calculation:**

It is important for property owners to understand that property tax bills are made up of two components – 1) the property tax rates which are set by the City Council and Wake County Board of Commissions and 2) the property's assessed value.

North Carolina State Statute requires a property tax neutral rate be calculated and published, although the rate is not required to be adopted. The property tax neutral rate is designed to calculate a tax rate that applies for the City as a whole, in other words the City's property tax revenues would be equal to the revenue estimate if the revaluation process was not conducted. Given the change in each individual homeowner's property assessed value will vary, some homeowners may receive a higher tax bill even at the revenue-neutral rate. The City's tax rate is based on many factors and is considered by staff and the City Council during the annual budget process, and ultimately adopted by Council.

#### **Next Steps:**

A public hearing has been set for the SOV on October 2, 2023, by the Wake County Commissioners. Specific to Raleigh, the Wake County Tax Administrator is scheduled to share results with City Council at a work session on January 16, 2024.

A few days later, assessed value notices will arrive in the mail to individual property owners.

#### **Moore Square Café Operations Update**

Moore or Less Empire, LLC, the operator currently responsible for food operations at Moore Square Café known as *Square Burger* since 2019, recently notified the City that they have elected to terminate their license agreement with the City effective January 14, 2024. A lot of work is planned in and around Moore Square to create a safe and welcoming area of the downtown. This includes a review of options for City—owned real estate assets adjacent to Moore Square, public safety improvements, review of programming, and other initiatives. PRCR will seek proposals for a new food operator at Moore Square through public solicitation. It is expected the open solicitation will start later this fall. This solicitation will generally include selection criteria related to the values of inclusive programming, creativity, experience, and knowledge of managing a food operation. Staff anticipates the process will span several months and hope to have a new operator in place by late spring. The recommended operator will be brought to the City Council for review and approval in the future.

#### **Urban and Community Forestry Grant**

The City was recently awarded a \$1,000,000 Urban and Community Forestry grant through the Inflation Reduction Act to help increase equitable access to trees and the many benefits they provide. Urban Trees deliver important benefits to society including cooling communities, improving mental health and wellbeing, increasing property values, and creating environmental jobs. Raleigh is one of 385 awarded projects where 100% of funding will go towards tree planting and maintenance in areas of greatest need.

As part of the award, the City will conduct community outreach and education, tree planting, pruning and removal of hazardous trees along the street, in City parks and other City properties in vulnerable communities. This work will provide new tree canopy, address safety concerns, improve tree health and resiliency, reduce extreme heat, and improve stormwater mitigation. This grant award comes at an opportune time as Wake County recently completed their county wide tree canopy assessment. Over the next several months, staff from multiple departments will work on an implementation plan that includes the assessment to address some of the City's goals including the Strategic Plan and Community Climate Action Plans and how best to use the grant funds to support these initiatives.

#### **GoRaleigh Access – Taxi Payments**

The GoRaleigh Access Program began using a new reservation and dispatch software (Ecolane) on August 1, 2023. Transit staff continue to receive feedback and educate Access riders and participating taxi companies on the intricacies of this new tool. In addition, RATP Dev, GoRaleigh's prime contractor, has been preparing the processes needed to pay all taxi vendors with the data generated from Ecolane.

As the Access system entered the second month of operation, vendor billing reconciliations for the first month revealed that Ecolane, by default and by industry standard, uses the shortest on street routing of a trip from origin to destination in lieu of the fastest routing. Historically, taxi companies have used Google maps to verify their trip distances. Google uses real-time variables in routing and provides options for shortest or fastest routing. Fastest routing calculates the use of interstates and highways that reduce time but results in greater milage.

Taxi companies have traditionally used the fastest route option when performing and billing for trips. The trip mileage variance between the shortest and fastest routing in the Ecolane software can account for up to 3 to 3.5 percent of a taxi companies monthly billing. In order to get all taxi companies paid as quickly as possible, RATP Dev is processing all taxi company payments for the month of August as the shortest route (RATP Dev payments are net 30 days). Once this payment is made, the default within the software will be changed for the month of September and beyond to the fastest routing in lieu of the shortest routing. A second payment will be processed for all taxi companies to account for the variance in August and all future billings will be paid based on the fastest routing.

We have provided this updated information to all taxi companies.

# Council Member Follow Up Items

Follow up from the September 19 Council Work Session

#### **Downtown Newsrack Kiosks Converted to Art (Council Member Melton)**

During the meeting, Council asked staff to address the aesthetics of modular newspaper kiosks located on Fayetteville Street between Morgan Street and Lenoir Street.

In September 2021, staff created an *Update* item to highlight a City initiated project to enhance these nine double-sided kiosks. With over 150 publication slots available and only 20% being permitted, five of the kiosks were converted to provide a highly visible canvas for displaying local artwork. An open call to artists was issued, and nine artists were selected through a jury made up of City staff and community partners. Selected artists received a \$500 honorarium to have their work printed on large metal panels along this

main downtown corridor. Participating artists included: Sampada Agarwal, Sydney Baldwin, Jane Cheek, Mayanthi Jayawardena, Tim Lee, Suijin Li, Shamica Phillips, JP Jermaine Powell, and Wendy Spitzer.

As of July 2023, four additional sides of newsrack kiosks were converted to art panels. These new selected artists included: Leslie Bartlebaugh, Molly Chopin, Christopher Williams, and Jessica Wood.

Only three of 18 kiosk sides are purposed for newsracks, which provides 22 slots available to publications. 17 slots are permitted. Two sides function as waste and recycling receptacles, and 13 sides display local artwork.


Staff further worked to improve aesthetics of remaining newspaper slots by replacing broken or damaged doors and creating new labels for permitted publications. It is also important to note that several of these kiosks are multi-purpose and serve as utility access points to power and water.

Courts have held that municipalities have only limited authority to regulate the placement of private newsracks in right-of-way if alternative means of distribution are not made available by the municipality. At the opening of Fayetteville Street, the use of the kiosks for distribution of publications, both paid and free, allowed the City to prohibit the placement of private newsracks along Fayetteville Street. The City Attorney's Office can provide additional information to Council on this area of regulation if desired.

A diagram and photos of the panels are shown below; more information is on the <u>City website</u>. Artwork displays on Fayetteville Street newspaper kiosks are a program of the Office of Special Events in partnership with Transportation, Facilities and Operations, and Raleigh Arts.




