Affordable Housing Summit Planning Update

Planning is underway for the 2024 Affordable Housing Summit. The Summit will be an opportunity for ALL Raleigh residents to learn about affordable housing in the City. The goals of the event are:

- 1. Education: teach Raleigh residents about what affordable housing is and strategies available to the City.
- 2. Engagement: cultivate space for residents to share dialogue about affordable housing challenges and needs in our community.
- 3. Innovation: identify new tools and ideas from the community and/or neighboring municipalities that the City could utilize.

The date and location of the Summit is tentatively planned for **Saturday, August 17** at the Raleigh Convention Center. The strategic choice of a Saturday aims to enhance accessibility for Raleigh residents, accommodating those who may face constraints in taking a typical workday off. We project the capacity to accommodate 150-300 attendees.

The format of the Affordable Housing Summit will follow a progressive structure, designed to facilitate a continuous learning experience for participants throughout the day. There will a diverse range of topics discussed by presenters, activities, and roundtable conversations. Our draft agenda is outlined below.

Five Points Intersection Safety Improvements

As part of the FY23 Capital Improvement Program, the Five Points Streetscape and Safety Study, initiated in Spring 2022, is dedicated to enhancing safety and accessibility at the intersection of Glenwood Avenue, Whitaker Mill Road, Fairview Road, and Glenn Avenue. Over the past two years, collaboration with Kittelson & Associates, residents, and stakeholders in the Five Points area has assessed current conditions, identified operational and safety issues, and engaged the public in narrowing down potential options for this intersection.

The Vision Zero Program has focused on addressing crash patterns at this intersection, employing a low-cost, high-impact approach. Recent improvements include a state-funded Spot Safety Project outbound (northwest) involving a speed feedback sign and flashing chevron signs on northbound Glenwood Ave. Before NCDOT implemented these changes, city staff upgraded pavement markings, added warning signs, and installed reflective markers for the northbound approach, particularly addressing nighttime crashes.

Additional enhancements by city staff encompassed a protected left turn phase for Whitaker Mill Road, a Leading Pedestrian Interval (LPI), extended pedestrian walk times, and replacing "green balls" with directional arrows for outbound traffic, enhancing safety at the signalized intersection near Hayes Barton Baptist Church.

Now that some time has passed since the improvements were installed, recent crash reports post-implementation shows a substantial improvement, with the annual average of crashes involving vehicles running off the road dropping from 3.8 to 1.6. This also includes the reduction of 1 fatal crash to 0 over the study period. The City's Vision Zero Program has successfully demonstrated that strategic, low-cost measures can result in a significant (~60%) annual reduction in targeted crash types. With Council's support and investment in the City's Vision Zero Program, this memo serves as an example that improvements can be made utilizing a low cost and tactical manner resulting in positive outcomes.

New Community Grant Program for Performing Arts Center

The Martin Marietta Center for the Performing Arts is launching a new grant program that will assist community organizations who have difficultly affording the cost of both renting and producing events in the venue. The grant will provide financial support to help offset venue rental and production costs for organizations that produce community-enriching events that are free and open to the public. One recent example of an event this grant program would cater to was the series of free events that were hosted in the Center in celebration of the Martin Luther King, Jr. holiday.

Applications for the program will launch next week and awardees for the program's initial round of funding will be notified at the beginning of March. While the program is not designed to support the entire cost of an event, evidence from recent events fitting the aforementioned criteria suggests that program support will significantly ease the financial burden for organizers of these events. The overarching intent of the program is to help accommodate and encourage future public events that add value and richness to the community.

Follow Up from the January 25 Council Retreat

<u>Provision of Basic Sanitation at Encampments on Government Property (Council Member Forte)</u>

During the retreat, Council requested an update related to an August 15, 2023 inquiry on the City providing basic sanitation at encampments on government property.

Recap

Staff previously provided the following updates on this topic.

- Most known large-scale encampments in Wake County exist on state-owned NC Department of Transportation (NCDOT) or private property. The May 22, 2023 Manager's Update summarized NCDOT's position on the installation of basic sanitation equipment (Porta Johns, portable showering facilities, trash collection receptacles, etc.) on sites maintained by NCDOT. Due to the significant threat to motorists, basic sanitation equipment is not generally permitted on NCDOT right-of-way.
- For City-owned property, the August 15, 2023 Manager's Update addressed potential legal implications identified by the City Attorney's Office (CAO) should the City choose to provide sanitary services.
 - In general, the CAO advises that the provision of these services directed on or at encampments could be viewed by an observer as at least tacit permission for the use of the property as an encampment.
 - This could create difficulty in enforcing code provisions such as camping, building and minimum housing code, and zoning code issues. (8/15/2023 update attached).
- Best-practice strategies for ending homelessness and closing encampments were also highlighted, including the <u>US Interagency Council on Homelessness (USICH) 7 principles for addressing encampments</u>.
 These principles underscore the importance of interagency cooperation; involving residents in solutions; conducting thorough outreach; meeting basic needs, providing shelter access; creating pathways to permanent housing; and planning for encampment site closure.
- The <u>Cities of Houston</u> and <u>Boston</u> were also cited as two examples of cities who have implemented coordinated policies based on these principles and seen success in addressing encampments and reducing unsheltered homelessness.
- Short term strategies to address health and safety should be balanced with long term solutions to end
 unsheltered homelessness. City staff will be exploring both in their interagency encampment strategy
 efforts. For both interventions, additional resources need to be identified.

Updates

• Staff is exploring funding options that would support the hiring of a consultant to help create an encampment response strategy. The creation of such a plan would help focus resources and strength outreach efforts to connecting people to services and housing. Staff plans to release a Request for Proposals to secure a consultant later this winter.

An inter-departmental workgroup has been convened to better assess the impacts of homelessness on
other departments with the goal of better coordinating efforts and resources. As part of this work, a
training has been scheduled for March 15, 2024, during which attendees will learn about root causes,
historical context, and the traumatic impacts of homelessness, as well as evidence-based practices and
principles; trauma informed care, strengths-based problem solving, low barrier, harm reduction, and
housing first, through a four-part breakdown.

Subject	Research Triangle Park Meeting Summary

At the direction of the ED&I committee meeting, staff met with Research Triangle Park's Research Triangle Foundation (RTF). RTF is an organization focused on orchestrating industry, university, and government collaborations. Staff met with two stakeholders from RTF: Tamara Terry from RTI International and Scott Levitan the President and CEO of RTF.

Staff provided RTF stakeholders with a briefing of the work of the ED&I committee and its conversations with Raleigh's two HBCUs, as well as a summary of the Mayor's Racial Equity Initiative in Charlotte. Tamara Terry discussed the RTP DEI Collective, a group comprising 50 companies in the RTP area that convene monthly to address diversity, equity, and inclusion (DEI) matters. Tamara emphasized community efforts with historically black colleges and universities (HBCUs), particularly North Carolina Central University (NCCU) and North Carolina A&T.

Tamara inquired about the alignment between the HBCU roundtable and the HBCU caucus³, expressing a desire to replicate successful initiatives from Charlotte in Raleigh. Scott highlighted his efforts to build results-oriented relationships with HBCUs, focusing on partnerships with North Carolina A&T and Shaw University. Scott outlined plans to advise Shaw University's Development Committee and create opportunities for internships and job placements with companies in the park, fostering collaboration between universities and corporations. Scott suggested that the continued promotion, cultivation, and ultimate success of the collaborations currently underway would increase the likelihood of successful fundraising efforts in the future.

The meeting concluded with RTF expressing interest in staying involved and connected, suggesting the replication of RTP's corporate partnership program in Raleigh. The

conversation between staff and RTF emphasized a commitment to DEI, economic development, and fostering partnerships between universities and corporations to create meaningful opportunities for students.
