Citizen Advisory Councils - Update

City Council gave direction regarding Citizen Advisory Councils at two recent meetings, by informal consensus at the City Council Retreat on January 27 and also by formal motion during the February 6 City Council meeting. Below are summaries of both actions and anticipated next steps.

City Council Retreat Summary

Draft notes from the City Council Retreat, as follows:

Following the 1-2-4 model, Council members answered, "What is the purpose of CACs today in the City of Raleigh" and identified the following shared statements.	
-	Two-way communication between the neighborhood/themselves, city government, and elected leaders.
-	An opportunity for Raleigh residents to be heard and participate in two-way communication.
-	A neighborhood partnership with the city.
-	Provide opportunities for citizens to interact and have discussions on issues impacting their community.
-	Provide opportunity for citizens to receive detailed updates.
-	hat CAC resource questions need to be addressed in implementation? Community center access (monthly frequency, if possible) Technology Recognition of the history of CACs Education and training for CAC leadership through existing programs.

Action: The Council unanimously decided to formally recognize the CACs as a community engagement partner of the city, without their prior role in zoning involvement.

Summary of February 6 Motion

Council voted to provide formal recognition and support of Citizen Advisory Councils in the following ways:

- Free monthly access to City facilities within the boundary of each CAC
- Free access to technology to facilitate streaming meetings

 Succession-planning opportunities to build participation and leadership for CAC's -Neighborhood College and Citizen Leadership Academy

Anticipated Next Steps

As was stated at the City Council Retreat on January 27 and restated on February 6, the City Manager committed to complete additional planning activities and bring recommendations to the City Council by late March or early April. A cross-departmental team has begun to meet to understand financial, technological, operational, and staffing needs and next steps necessary to act on City Council direction. While staff will look for opportunities for early action on implementing some requests, many requests will require longer-term planning and investment and are not anticipated to be possible until July 2024. Additionally, given the need to fully define the support provided to CACs and the potential impact of those decisions on organizations that will become part of the engagement network, staff recommends delaying the launch of the network. The original implementation timeline envisioned promotion of the network to begin Monday, February 12 with a "go-live" date of Monday, March 11. This timeline will be updated and amended as necessary based upon the outcome of the abovementioned discussions.
