Council Member Follow Up Items

Follow up to the September 17 Council Meeting

Cooper Road Stormwater Issue (Council Member Branch)

During the meeting Council requested information about a stormwater flooding issue on Cooper Road, as there have been reports of stormwater ponding on the road during storm events. The Stormwater maintenance staff has investigated this area and determined that the issue can be traced to a possible pipe collapse located on a private property downstream of Cooper Road.

Stormwater staff contacted the property owner and will be meeting with them the first week of October to request access to the property to further investigate the issue. Once this has been investigated further, staff will determine how to address this issue moving forward. The immediate priority will be developing a plan to clear the pipe on private property (if the property owner agrees to allow the City to access the property) to address the stormwater ponding on Cooper Road during storm events. A potential longer-term solution will be to work with affected property owner through the Stormwater Drainage Assistance program to address this problem. If the property owner opts to participate in the Drainage Assistance program, granting the city an easement for the drainage structures on the property would be required. This would allow the City to maintain the stormwater structures on this property after the City has completed any work associated with the Drainage Assistance project.

Currently Stormwater Maintenance staff is installing signage on Cooper Road to alert drivers of potential road flooding during storm events. Once Stormwater staff has met with the property owner and obtained access to the property, the long-term stormwater plan can be finalized.
