USGS Streambank Erosion Study Status and Update

Council requested that Stormwater staff keep them updated on the status of the Streambank Erosion Study being conducted by USGS with support funding from Raleigh Stormwater. This request was a follow up to the presentation referencing this study made by Stormwater staff related to streambank protection initiatives at the October 22, 2024, Growth and Natural Resources (GNR) Committee meeting.

An overview of the study and data releases are available on the <u>USGS website here</u>; a separate <u>Project</u> <u>StoryMap titled "Finding Erosion Hotspots in Raleigh, NC</u> has been developed with the latest findings. Study results must go through USGS' extensive peer review process prior to the final report being released. In the March 2025 City Manager update, <u>Update 2025-12</u>, stormwater reported that the final report was anticipated this fall. However, due to changes in federal staffing levels, the release is now projected for March 2026.

Stormwater staff are currently preparing more detailed information as to how this study will be used to guide the City's overall stream protection programs along with additional stream protection recommendations in response to the GNR Committee's request.

CASA Grosvenor Gardens Deeper Affordability

In 2022, Council authorized \$2,000,000 for CASA to acquire Grosvenor Gardens, a 62-unit historic and naturally affordable rental housing property. The City's acquisition loan included the following restrictions:

80% AMI	Fair Market Rent	Unrestricted	Affordability Period
29 units	29 units	4 units	30 years

In April 2025, Council authorized an additional \$1,200,000 to CASA for the rehabilitation of Grosvenor Gardens with the following restrictions:

30% AMI	60% AMI	Unrestricted	Affordability Period	City Referral Set-Aside Units
7 units	51 units	4 units	50 years	3

As staff worked with CASA to draft the loan agreements for the additional \$1,200,000 funds, combining the existing acquisition loan with the new funding, and combining their respective restrictions, was proposed. Staff recommend amending and restating the previous \$2,000,000 acquisition loan to be combined with the new \$1,200,000. The combined \$3,200,000 loan will contain the more restrictive affordability terms approved by Council in 2025. These changes will provide the City with deeper affordability for a longer period of time.
