


To whom it may concern:

Upon inspecting the Maple (approximate DBH 14") located at 112 N East St. Raleigh, NC 27601, I recommend this tree as a candidate for tree removal. The canopy is showing signs of thinning and overall decline. Branch and canopy stress can be observed on the street side canopy, following continual improper pruning cuts made to the large branches by the power company.

The stem shows at least 2 visible areas of exposed internal decay, which carries down into the root zone. Phytophthora Root Rot Canker was noted at the base/root flare of this tree, contributing to overall tree stress and decline.

If the tree were left in place, it would continue to decline until fully dead. Should this tree fail, it has the potential to negatively impact the homeowner's property or adjacent power lines. Removal is the best course of action to eliminate the risk of failure.
