



#### Brief Description of Work:

The proposed work associated with this Minor COA application is to install a mini-split ductless HVAC system on the third floor of the property. This will involve installation of a small exterior compressor unit (see photo for an illustration of the exterior unit). Unlike the photo, this unit will be installed on the a ground pad and will be adjacent to existing compressors for the main level of the house. A lineset will run up the exterior wall to provide power and cooling/heating properties to the interior of the house. This will be covered in a white enclosure similar to the photo. This work will take less than one week to complete.

I am attaching several items.

- 1) Picture of the front of our house
- 2) Picture of area where new HVAC unit will go it will be to the right of the existing HVAC units in the photo
- 3) A site plan (survey and sketch) showing the proposed location
- 4) The specification sheet for the unit which has dimensions as requested.

As to the matter of the covering for the line set, I would prefer to have this be enclosed in a PVC pipe similar to how my electric line comes in from the street and down to the meter. See attached picture - this would be painted the same color as the house and would be very discrete and in my opinion the best approach. The system we will install comes with a plastic lineset cover that can be painted white to match our trim. Alternatively, if we cannot use this, we would use a white aluminum k-style downspout to match our existing downspouts. As I mentioned my preference is to use a PVC pipe as is used for the electrical service line.






