Add Black Wrought-Iron Handrail to Right Side of Front Stairs for Safety

A handrail will be added to the right side of the front steps to meet code for safety. The proposed rail is simple in design (no decorative embellishments other than thin vertical pickets) and its appearance will match the black wrought iron fence located at the front of the property. This will help it recede into the background and be unobtrusive on the primary façade of the house.
