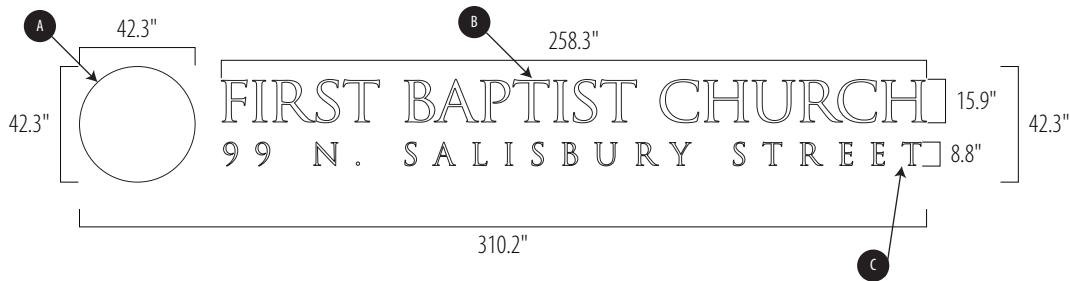

C: 3/8" white acrylic lettering, stud mounted flush to fascia



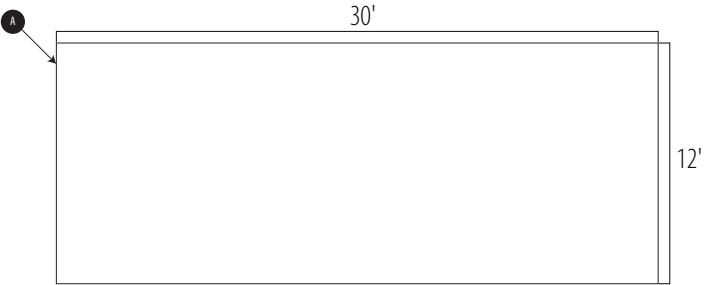

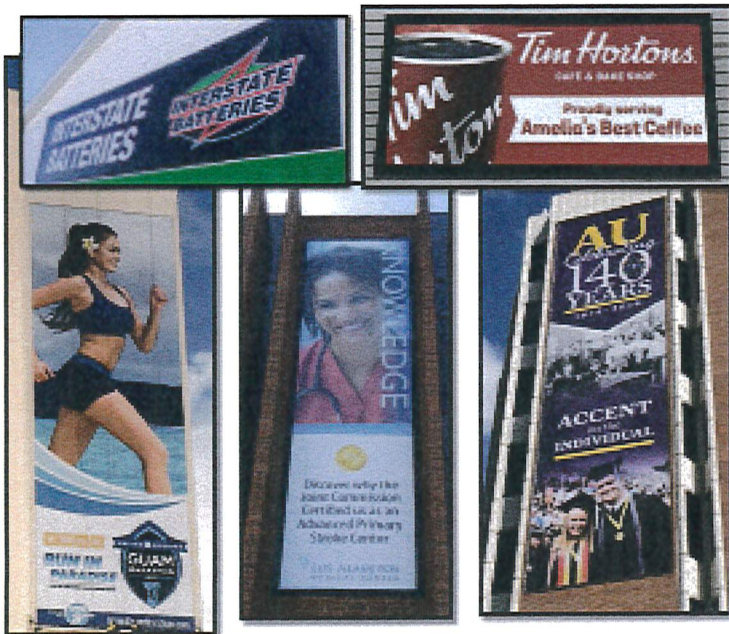
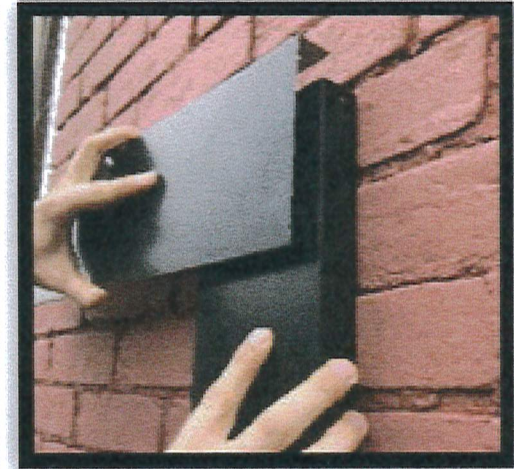
