On the rear of my property, 906 Dorothea Dr., there is an old water oak. Despite attempts to treat and defeat both borer beetles and phytophthora canker disease with Bartlett Tree Experts, it has succumbed and is now almost or completely dead. Due to its large size, ~48" in diameter, it poses a risk to anything underneath its large canopy and I would like to have it removed.

As noted in one of the attached arborist letters, planting another water oak is not advisable and they have recommended planting a tree of a smaller species. I will plant a Japanese Maple towards the front of the property as a replacement as indicated on one of the site plans.

Bartlett Tree Experts inspected an Oak tree at the property at 906 Dorothea Dr. in Raleigh. After my visual inspection, the tree is in decline. Large limbs have already failed and more than 1/3 of the entire canopy is dead and hazardous. The canopy that is dead already has Hypoxolyn Canker which is a sign dead or dying limbs. This canker is very dangerous and unpredictable. This tree needs to be removed as soon as possible before any other tree failures occur.

Replacement Tree for the large declining Water Oak:

Given the size and location of the Water Oak, I recommend a smaller species of tree to replace the Oak. The canopy from other surrounding trees overhangs and shades the backyard. If a similar species was replaced, it would not have enough sunlight to develop into a major shade tree. A species that grows well in a high shade area would be more suitable for the area.

Hi Harry,

Hope you are doing well. I wanted to check in before the end of the week to see where we are on receiving the remaining site plan and replacement tree information for your minor work COA. In case it is unclear in previous emails, the removal of the diseased tree on your property without an approved COA in hand is considered a violation. Completing approval is a quick process on our end once we have the remaining items. During the COVID-19 stay-athome orders, we are able to email the required blue placard instantly and will follow up with a mailed copy a few days later.

With regard to the documents, my hands are tied until my arborist can back to me (I'm cc'ing him in this email thread). For your records, the tree dropped another limb in the most recent rains.

Per our previous email and your departments request given the circumstances, I have agreed to a replacement tree. The current tree was diseased, it is now dead and dangerous. Again, this tree dropped limbs on the alleyway last Thursday where City of Raleigh employees picked up trash and recycling not even an hour later. This could have injured/killed someone or damaged persona/city property.

I know it is a violation to take down a tree without complete approval. What would you do in my situation? Is a violation worth the mitigated risk of a limb dropping atop a child riding their bike through the alleyway? I can only hope that you would feel the same if you were in my shoes.

Following our most recent emails, I assume that you have moved forward with scheduling tree removal. Please make sure to submit the remaining documentation quickly so that we can finalize approval before workers arrive on site. This will avoid undertaking work in violation and prevent any delays with the scheduled workers. Please let us know. Thank you.

After this threat is gone, I would like to start a formal request to alter this process. For imminently dangerous trees, especially during extenuating circumstances, waiting this long to approve is borderline negligent in my view. Can you direct me to someone or something that can explain what that process entails, please?

We need to find a sane balance between preserving the quality and character of our neighborhoods with common sense and safety for the people living there.

Harry,

I believe we can get to a place where the application can be approved as a minor work quickly. Staff is bound by the bylaw procedures and list of work to require a replacement tree as a part of the minor work approval; however, we have a quicker approach to this process to allow you to begin removal immediately given the dangerous nature of the tree.

I understand. Thank you for being both professional with the stressful nature of this and diligent in your duties.

Under special circumstances such as these, we have in the past allowed flexibility for the replacement tree to be of a different understory species so that you don't have to worry about crowding the canopy or that a good location for a tree of that size is not available. To be clear, the replacement tree does not need to be planted in the exact same spot, just somewhere on the property. The understory tree can even be planted in the right-of-way out front. We would just need material from you to demonstrate that a replacement tree of similar species cannot be planted on the property. We also still need a site sketch showing the proposed location and species of the new tree.

We had not thought of planting a replacement oak elsewhere on the property. I've reached out to my arborist regarding the two options. If they agree another oak, elsewhere on the property, would do well I am happy plant one. If not, I've requested a document supporting the claim that a different species would is better suited.

This literally just happened. That could have fallen on my car had I not moved it or someone walking through the alley. Please help me expedite this.

Erin,

Given the height and spread of the dead water oak, I do not believe it would be possible to plant another oak that would fill out in the same way. When asked, both arborists I had verify the death and threat of the water oak, stated the other large trees on my property, and my neighbors, would fill in this negative space.

Is another, already existing oak over 3" in diameter that stands higher than the utility poles in the alleyway sufficient? It is the most likely 'young' oak that could potentially grow into the canopy.

I looked over the <u>COA schedule</u> and, if I am reading this correctly, the quickest hearing I could hope for would be an application deadline of May 13th for a hearing on June 25th. That date is eight weeks away and more than <i>three weeks after the beginning of the hurricane season</i> . This tree has already dropped two large limbs and needs to be removed now.
There must to be a special case for situations that are an imminent threat, right? Nothing that I saw in the guideline discusses issues that are time sensitive. What would happen if the tree had already fully fallen or partially fallen?
Can you please help, escalate, or direct me to someone who has dealt with a similar scenario? All of the small limbs have already fallen. Some major ones have already fallen too. Now only the largest, most life threatening ones are left and they are over both my bedroom as well as the alleyway which neighbors, children, and City of Raleigh workers use daily.
For what it's worth, the previous owner let these trees and the house fall into disrepair. I have spent innumerable hours, too much money, and too much stress rectifying decades of poor maintenance around this property. For this tree alone, under the guidance of an arborist, I have spent two years treating at the cost of \$3,000 trying to save it.
I'm sad for the loss of this water oak despite years of treatments the trees are why I moved and bought here. I am frustrated for a (this) process that neighbors and friends warned me to avoid because it couldn't understand nuances (danger) for this situation. I am scared each time I go into my bedroom that one of those limbs will injure someone or something and force us to handle an even worse predicament during this pandemic.

I cam begin filing the major COA paperwork today. But please, please, please let me know if there are any alliterative options. Per my arborist, 'This canker is very dangerous and unpredictable. This tree needs to be removed as soon as possible before any other tree failures occur.'

Harry,

We have made an initial review of your application. In order for the application to be approvable at the staff level, we will need one additional item. The evidence you have provided to show the diseased nature of the water is considered adequate. All minor work removals of diseased trees require that a replacement tree of a similar species be planted in its place somewhere on the property. The replacement tree should be planted with a minimum 3" caliper and grow to a similar mature size and canopy as the existing tree. Can you provide an accurate site sketch of the location of all existing trees on or near the property and indicate a proposed location and species for the replacement tree?

If you are not in favor of planting a replacement tree, you are able to submit a major work COA application to be heard by the COA committee. If you would prefer to pursue this option, please let us know and we can provide additional information on the process. Thank you!
