# Written description of work (710 Devereux Street):

The oak tree that is dying is in the front of our house, and is next to the City's sidewalk and then Devereux Street. We noticed last year that the bark on the back side of the tree (facing our house) started popping off. This spring, as the healthy parts of the tree started leafing out, about ½ of the tree did not leaf out and there was left only dead branches, and there has been significant amounts of dead limbs falling into the yard. The bark has continued falling off in much larger amounts.

We requested that the City's arborist come out to our property to do an assessment, not only on the health of the tree, but also whether the tree is on City property or our property. She brought with her another arborist for collaboration. They determined that the tree is on our property, and also that the tree is in very bad condition and definitely dying. The large limbs on one side of the tree that are dead, will potentially break away from the main tree and fall, causing significant damage to property and potentially people. The tree has a significant branching of two main trunks, and could potentially split along that juncture and, again, cause significant property and personal damage.

Their recommendation was that the tree should be removed because it cannot be saved at this point, and it could potentially cause extensive property damage to our house, our neighbor's house across the street, and to people parking and/or walking along our street. There is an elementary school one block from our house, and parents park in front of our house on both sides of the street when dropping off and picking up their children. Plus, because of Fred Fletcher Park within blocks and the restaurants and bars a few blocks in the other direction, many people park along our street and walk to their destinations.


Many of our neighbors have enlisted the services of and highly recommended Tree Men Services LLC. The owner, Isai Rodriguez, came to the house to do an assessment and agrees with the City's arborists that the tree is dying and could definitely be a danger to our house, our neighbors' houses, and people. His company is the one that would remove the tree, and his evaluation letter is attached.

# Tree to be planted as a replacement to the tree removed:

### Bur Oak Tree (Quercus Macrocarpa)

- Height: up to 80-100 feet Canopy: up to 80 feet;
- Very tolerant of urban conditions;
- Long-lived specimen tree;
- Tolerates different kinds of soil;
- Tolerates heat and drought once established;
- Produces abundant acorns, both large in size and in quantity;
- Grows quickly.
