Hello there,

We are seeking a Minor COA approval for the repainting of 318 Cutler St. in the Boylan Heights neighborhood of downtown Raleigh. Our house is in desperate need of a repainting as there is chipping, fading, and worn down spots. Because our house is over 100 years old, we also know there is lead paint on our property. We want to maintain our home, bring it back to life, and add just a touch more diversity to the overall very gray look of the home.

Because of the lead paint, we will be using a Lead Certified paint company: Matrix Painting Inc. (<u>https://www.matrixpaintinginc.com/</u>) who will ensure that the work is done well and properly according to all local regulations.

We are seeking to maintain as much character as we can in the home, while also bringing it life with a few small changes. We have sought to use some colors from the Historic Line from Sherwin Williams, and all specific colors can be found below.

Looking over the guidelines for RHDC, we hope the following paint schedule will bring our house to life and keep its original character alive for many more years.

CHANGE: The following will be a repaint using new colors Wood Siding: SW 6202 - Cast Iron Front Porch Ceiling: SW 0056 - Classic Sand Front Porch Floor: SW 7540 - Artisan Tan (they will use porch paint for this)
