Rear Door Replacement for 322 E Davie St.

We have 6 glass panel with wood edging doors on the back portion of the house that need replacing due to rot from lack of protection from rain water and sun. This back portion of the house is an already renovated portion of the home completed in 2014. It included these 4 glass doors off the kitchen and set of 2 of the same doors off the primary bedroom all leading onto the deck.

We are working with Bob VonDoster Restoration to have these doors replaced. Bob, along with Tim, from American Cedar and Millwork, have advised fiberglass as replacements. They also noted the back doors on neighboring homes within sight of the back of our home (324 Davie, & 408 and 412 Bloodworth) also appear to be fiberglass &/or vinyl.

Bob has made himself available for any further questions and has said: "You need fiberglass due to the exposure to water and direct sunlight." I'm including cut sheets from Tim. These fiberglass doors have the same profile and edging as the existing wood doors and will be painted exactly as the current doors for a like-to-like appearance.
