
State Employees' Credit Union currently owns and occupies the structure, and as the caretaker, we are committed to maintaining the historical integrity of the site, while ensuring proper maintenance and preservation.

We have been advised that the roof drainage system has been become compromised and are exploring options to remedy this concern. Over the past few years, clogging of the drainage gutter system has been caused by debris from nearby trees falling into the gutter. As this debris falls and clogs up the gutters and drainage, the rain then proceeds to pour over and run down the façade of the building causing deterioration to the stone, mortar, and stucco on structure. After much research on the site and what we can do to circumvent the drainage issue, installing a set of gutter guards on the existing gutters to prevent clogging and at the same time preserving the building seems to be a very viable option.


