


## Written Description: 614 Polk St.

We would like to repaint our home in historic oakwood and change the paint colors. The home will first be carefully washed. Any chipped paint will be scraped or lightly sanded off with care taken to the siding. Any siding, trim or fascia pieces that are rotten will be replaced with matching material. The home will then be primed and painted with our desired colors. The body of the house will be painted in Sherwin Williams Iron Ore. The trim will stay a white of Sherwin Williams Extra White. The porch floor will stay a grey, specifically, Sherwin Williams CityScape. The window sash will stay a black, specifically, Sherwin Williams Tricorn Black. The porch ceiling will change to Sherwin Williams Extra White. The brick foundation has previously been painted. We would like to keep it a brick color of Sherwin Williams, Fired Brick. Care will be taken and plants and trees will be covered.


