## Luther Meredith Interment, City Cemetery

Raleigh City Cemeteries Preservation Inc. (RCCP) a 501 (C) 3 friends group to the City of Raleigh respectfully requests that the Raleigh Historic Development Commission approve our COA for a minor work.

We would like to place a grave marker for the infant Luther Meredith, son of Thomas Meredith, benefactor of Meredith College in City Cemetery, Raleigh, NC. From Wikipedia:

Thomas Meredith (July 7, 1795 – Nov.13, 1850) was an influential Baptist pastor, one of the founders of the Baptist State Convention of North Carolina, and the founder and editor of the Biblical Recorder newspaper. In 1819 Meredith married Georgia Sears, and they had 11 children. Meredith was well-known- he was the pastor of several churches located in New Bern, Savannah and Edenton. He was a strong supporter of education, including the Wake Forest Institute (now Wake Forest University), launched in 1834, and the first president of its board of trustees. Unusual for the time, he supported the higher education of women, and called for the Convention to establish "a female seminary of high order." Nothing was done at the time, but eventually the Baptist Female University was chartered in 1891, opened in 1899, and in 1909 renamed Meredith College in his honor.

RCCP restored the obelisk grave marker for Thomas Meredith in 2011. The project was funded by the NC Baptist Convention and the work was completed by restoration specialist Dean Ruedrich (before and after photo below, left).







In 2014, RCCP board member and historian Betsy Shaw researched the Meredith family and found a newspaper account that mentioned young Luther was buried with his father in City Cemetery. In 2015, Danny Morgan, then Raleigh City Cemetery Superintendent, he conducted a probe of the plot \((Betsy))

and Danny shown above on right). The probe revealed that a second grave was most likely located to the right of the base of the obelisk.

In February 2019, we found a descendant of Thomas Meredith through Meredith College, John Ralls, who gave us permission to mark the grave of young Luther next to his father: Email dated 2/11/19:

"Jane, Yes, I'm a descendant. The Ada Tolson Ralls who painted the portrait at Meredith College was my great-grandmother. I'm all in favor of a marker for Luther, even if he's not buried with Thomas, as if there are no records it's unlikely that we'll ever find where he really is. That said, it seems unlikely that Luther would have been exhumed and reburied when his father died 13 years later, so if they're together it's because that's where Luther was buried. Even if there's no record of the child's interment I'd expect a plot record showing Thomas's ownership dating from 1837.... Regards, John Ralls

The marker will be a simple rectangle, 24 inches wide by 12 inches tall, installed in City Cemetery by Wake Monument Company to the right of the obelisk base:

Luther Meredith
Son of Thomas and Georgia Meredith
Died at 19 months

January 1836-August 12, 1837

RCCP will pay for the cost of the monument.
