

Purpose of Today's Public Meeting

The purpose of today's public meeting is to provide you with information on the project and to get your input on the proposed design. You are encouraged to provide comments on the proposed project. Project Description

This project is in the 25 percent design phase and has been prioritized as a major street project by the Capital Improvement Program.

The project proposes to widen a segment of Blue Ridge Road (S.R. 1670) from Duraleigh Road (S.R. 1664) to Crabtree Valley Avenue to three lanes, including installation of curb and gutter, a center turn lane or median, improved bus stops, traffic signal upgrades, streetlight upgrades, sidewalks, bicycle lanes, and enhancements to the existing street crossing at the House Creek Greenway. The project will have the features of a divided avenue. This includes a 40 mph design speed and a minimum right-of-way width of 75 feet with a center turn lane, or 80 feet with a raised median.



Project Purpose

The purpose of this project is to provide a functional and safer multi-modal corridor for vehicles, cyclists, and pedestrians.




