## PROJECT OVERVIEW



The project area is located in Northeast Raleigh. It consists of approximately six miles of proposed bicycling and walking improvements. It also includes intersection improvements to benefit both bicyclists and pedestrians.

The design includes the following elements in one or multiple locations:

- curb and gutter
- drainage features
- sidewalks
- bike lanes/buffered bike lanes
- refuge islands
- bicycle turn boxes
- multi-use trail
- roadway widening
- pedestrian signals
- guardrails
- bicycle two-stage turn queue box
- green paint in conflict areas

## NEXT STEPS

This First Meeting regarding the 25% design for the project is a continued part of a public involvement program for the proposed project and its purpose is to address the concerns of local citizens during the design process. Participation by all interested parties is encouraged and all comments will be taken into consideration during the design of the project. The City of Raleigh will notify citizens of the Second Public Meeting tentatively scheduled for Spring 2018.
