Project History

- Major east-west commuter route to and from Downtown Raleigh.
- Divided one-way pair from the State Capitol to Poole Road and four-lane median divided roadway from Poole Road to I-440.
- Improve the connectivity of pedestrian and transit facilities.
- Consistent with the New Bern Ave Corridor Study (Adopted January 2012).


Project Purpose

 Improve the connectivity of pedestrian and transit facilities along New Bern Avenue






- Proposed multimodal improvements to New Bern Avenue from Tarboro Street to Sunnybrook Road
- 2.2 mile length




- Section 1
 - Between Tarboro Street and Raleigh Boulevard
 - 14-foot-wide sidewalks on the back of curb
 - Upgraded transit stops
 - LED street lighting, streetscape, and landscaping
- 0.5 mile length












- Section 2
 - Between Raleigh Boulevard and Sunnybrook Road
 - 8-foot-wide sidewalk/multi-use path with a greenway style alignment
 - Curb and gutter where required to minimize footprint and stay within the existing right-of-way
 - 1.7 mile length














 Pedestrian/traffic signalization modifications and drainage improvements will be added where required along both sections of the project corridor


