

## Project Schedule

Assessments for the curb and gutter will be at an anticipated rate of \$32.00 per frontage foot for residentially zoned properties and \$64.00 per frontage foot for non-residentially zoned properties.

## Project Details

**Location:** The proposed project will extend Pullen Road from Western Boulevard to the south, connect to a proposed roundabout at Bilyeu Street, and then extend to the southwest to tie into the existing Centennial Parkway / Oval Drive Intersection.

**Need/Benefit:** The Pullen Road Extension will enhance connectivity between Western Boulevard and Centennial Parkway and will provide a corridor for both vehicles and pedestrians.

### Description of Roadway:

- The Pullen Road Extension is 2-lane divided roadway with bike lanes between Western Boulevard and the proposed roundabout. The proposed speed limit is 25 mph.
- The proposed roundabout will connect the Pullen Road extension with Bilyeu Street and has a 120' diameter.
- Bilyeu Street will consist of a 2-lane divided roadway with bike lanes to the west of the proposed roundabout. The proposed speed limit is 25 mph.
- Street trees, street lighting, a 10' multi-use path, and sidewalks are proposed along the corridor.

**Traffic Maintenance:** Local traffic operations on existing Western Boulevard, Centennial Parkway, and Bilyeu Street will be maintained during construction. There will be brief periods of one-lane, two-way traffic controlled by flaggers during non-peak travel times.
