Neighboring Property Owners and Tenants:

You are invited to attend a neighborhood meeting on May 8, 2023, from 6:30 pm – 8:00 pm. The meeting will be held at the Barwell Road Community Center – Meeting Rm. 2 at 5857 Barwell Park Dr., Raleigh, NC 27610 and will begin at 6:30 pm.

The purpose of this meeting is to discuss a potential text change to existing zoning conditions applicable to the property located at 4216 Whitfield Rd., Raleigh NC at the intersection of Battle Bridge Road and Whitfield Road. This site is currently zoned R-6-CU. No change to the existing zoning classification is proposed, however, the property owner does propose to change the existing zoning conditions in a manner that would permit a church to be constructed on the property.

The City of Raleigh requires that a neighborhood meeting be held for all property owners and tenants within 500 feet of the property which is subject of the proposed application for text change to zoning conditions.
