### Re: Notice of Second Neighborhood Meeting

Neighboring Property Owners and Residents:

You are invited to attend a second neighborhood meeting on July 29, 2025, from 7:00-8:00pm in the fellowship hall of St. Matthew Baptist Church (SMBC), located at 5410 Louisburg Road, Raleigh, NC 27616. The purpose of the meeting is to discuss Z-17-25, the requested rezoning of 4 parcels of land located at 5305 Louisburg Road (PIN: 1726948726), 5309 Louisburg Road (PIN: 1726948878), 5401 Louisburg Road (PIN: 1726949937), and 5419 Louisburg Road (PIN: 1736050035) (the "Site"). The Site is currently zoned Residential-1 (R-1) and this proposal would rezone the Site to Residential-10-w/ Conditions (R-10-CU). During the meeting, the applicant will describe the nature of the request, provide updates since the first neighborhood meeting, and field any questions from the public. Enclosed are: (1) a vicinity map outlining the location of the parcels; and (2) a current zoning map of the subject area.

After the Rezoning Application has been filed, but prior to review by the Planning Commission, the City of Raleigh requires that a second neighborhood meeting for certain rezoning applications be held for all residents and property owners within 1,000 feet of the area requested for rezoning. After the meeting, a report will be submitted to the Raleigh Planning and Development Department. Any other person attending the meeting can submit written comments about the meeting, but to be included in the Planning Commission agenda packet, written comments must be received at least 10 days prior to the date of the Planning Commission meeting where the case is being considered.
