

ORDINANCE NO. 2018 – 795 ZC 758
Z-30-17 – OBERLIN VILLAGE HOD-G

**AN ORDINANCE TO AMEND THE ZONING ORDINANCE OF THE
CITY OF RALEIGH WHICH INCLUDES THE ZONING DISTRICT MAP**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RALEIGH:

Section 1. That Part 10 of the City of Raleigh Code, which includes the Zoning District Map be, and the same is, hereby amended as follows:

Z-30-17 – Oberlin Village, multiple properties located within the Oberlin Village neighborhood, including areas east and west of Oberlin Road and roughly bounded by Wade Avenue on the north, Bedford Avenue on the south, Daniels Street on the east, and Chamberlain Street on the west, as referenced by PIN and address in Attachment A. Applies General Historic Overlay District (HOD-G) to approximately 24 acres zoned Residential-6, Residential-6-Conditional Use, Residential-10, Residential Mixed Use-3 stories-Conditional Use, Office Mixed Use-3 stories, Office Mixed Use-3 stories-Parking Limited, Office Mixed Use-3 stories-Parking Limited-Conditional Use, and Office Mixed Use-3 stories-Urban Limited and zoned partial Neighborhood Conservation Overlay District and partial Special Residential Parking Overlay District.

Section 2. That completed applications for permits, site plans (including subsequent related building permits) and subdivisions received by the City prior to the effective date of February 6, 2018 shall be processed by the City in accordance with the applicable standards and procedures existing at the time of submittal.

Section 3. That all laws and clauses of laws in conflict herewith are hereby repealed to the extent of such conflict.

Section 4. That if this ordinance or any application thereof is held invalid as to any person or application thereof, such invalidity shall not affect other provisions or applications of the ordinances which can be given separate effect and to that end the provisions of this ordinance are declared to be severable.

Section 5. That this ordinance has been adopted following a duly advertised public hearing of the Raleigh City Council following a recommendation of the Planning Commission.

Section 6. That this ordinance has been provided to the North Carolina Capital Commission as required by law.

Section 7. That this ordinance shall become effective as indicated below.
