


Narrative of Zoning Conditions Offered

- 1. The following Principal Uses as listed in UDO Section 6.1.4. that are permitted, limited, or special uses in the CX- zoning district shall be prohibited: (i) Dormitory, fraternity, sorority; (ii) Emergency Shelter Type A; (iii) Emergency Shelter Type B; (iv) College, community college, university; (v) Adult establishment; (vi) Outdoor Recreation; (vii) Golf course; (viii) Overnight Lodging; (ix) Hospitality house; (x) Passenger Terminal; (xi) Heliport, serving hospitals; (xii) Heliport, all others; (xiii) Brewery, winery, distillery, cidery; (xiv) Light Manufacturing; (xv) Research & Development; (xvi) Self-Service Storage; (xvii) Vehicle repair, major; (xviii) Single-unit living; (xix) Two-unit living; (xx) Cemetery; (xxi) Outdoor sports or entertainment facility (>250 seats); and (xxiii) Vehicle sales.
- 2. The following Principal Uses as listed in UDO Section 6.1.4. that are permitted uses in the CX- district shall be limited uses: (i) Bar, nightclub, tavern, lounge.
- 3. The total number of vehicles capable of being simultaneously serviced by Vehicle Fuel Sales shall not exceed four (4).
- 4. Hours of operation for vehicle fuel sales (including gasoline and diesel fuel) can begin no earlier than 6:00 AM and end no later than 11:00 PM. Operations includes and deliveries and collections. Preparation, store cleaning and inventory may be allowed during these restricted hours. Uses other than Vehicle Fuels Sales (including gasoline and diesel fuel), car washing and vacuuming may continue operation during these restricted hours.
- 5. All vacuuming and compression machines located outside of an enclosed building must be located at least fifty feet (50') from a Residential district.
- 6. Accessory car washing is only allowed if the car wash is equipped with fully automatic wash equipment so the driver remains in their car during the entire wash process.
- 7. Back-lighting of fuel canopies is prohibited. All canopy lighting shall be flushed mounted underneath the canopy except for the signs.
- 8. Canopies shall be limited to sixteen feet (16') maximum height to the bottom of the underside of the canopy and a twenty-three feet (23') maximum height to the top of the roof of the canopy (absent any required vent stacks).

	Buildings should be located close to the pedestrian-oriented street (within 25 feet of the curb), with off- street parking behind and/or beside the buildings. When a development plan is located along a high- volume corridor without on-street parking, one bay of parking separating the building frontage along the corridor is a preferred option.

8	If the site is located at a street intersection, the main building or main part of the building should be placed at the corner. Parking, loading or service should not be located at an intersection. Response:
9	To ensure that urban open space is well-used, it is essential to locate and design it carefully. The space should be located where it is visible and easily accessible from public areas (building entrances, sidewalks). Take views and sun exposure into account as well. Response:

	in commercial areas and Pedestrian Business Overlays should be a minimum of 14-18 feet wide to accommodate sidewalk uses such as vendors, merchandising and outdoor seating.

22	Streets should be designed with street trees planted in a manner appropriate to their function. Commercial streets should have trees which complement the face of the buildings and which shade the sidewalk. Residential streets should provide for an appropriate canopy, which shadows both the street and sidewalk, and serves as a visual buffer between the street and the home. The typical width of the street landscape strip is 6-8 feet. This width ensures healthy street trees, precludes tree roots from breaking the sidewalk, and provides adequate pedestrian buffering. Street trees should be at least 6 1/4" caliper and should be consistent with the City's landscaping, lighting and street sight distance requirements. Response:
23	Buildings should define the streets spatially. Proper spatial definition should be achieved with buildings or other architectural elements (including certain tree plantings) that make up the street edges aligned in a disciplined manner with an appropriate ratio of height to width. Response:
24	The primary entrance should be both architecturally and functionally on the front facade of any building facing the primary public street. Such entrances shall be designed to convey their prominence on the fronting facade. Response:

REPORT OF MEETING WITH ADJACENT PROPERTY OWNERS AND TENANTS ON SEPTEMBER 20, 2023

Pursuant to applicable provisions of the Unified Development Ordinance, a meeting was held with respect to a potential rezoning with adjacent neighbors on Wednesday, September 20, 2023 at 5:30 p.m. The property considered for this potential rezoning totals approximately 0.36 acres, and is located northwest of the Bashford Road and Buck Jones Road intersection, in the City of Raleigh, having Wake County Parcel Identification Number 0773-98-3036. This meeting was held at the Method Road Community Center, located at 514 Method Road, Raleigh, NC 27607. All owners and tenants of property within 500 feet of the subject property were invited to attend the meeting. Attached hereto as **Exhibit A** is a copy of the neighborhood meeting notice. 
The property totals approximately 0.36 acres in size and is located northwest of the Bashford Road and Buck Jones Road intersection. The property is currently zoned Neighborhood Mixed Use, 3-story height limit (NX-3) with the Transit Overlay District (TOD). The proposed zoning is Commercial Mixed-Use, 3-story height limit, conditional use (CX-3-CU), and would remove the TOD. The purpose of the rezoning is to permit Little Sue Mini Mart to resume gasoline sales.

The City of Raleigh requires a neighborhood meeting involving the owners and tenants of property within 500 feet of the property prior to filing the rezoning application. After the meeting, we will prepare a report for the Planning Department regarding the items discussed at the meeting.




EXHIBIT C – ITEMS DISCUSSED

Question: What is the rationale for rezoning to Commercial Mixed-Use (CX-)? Answer: The NX- base district imposes additional use regulations on the sale of gasoline, and this property cannot feasibly conform to those regulations. The CX- district does not impose those regulations on gasoline sales.

Question: Who owns the adjacent lot that is used for U-Haul rentals?

Answer: Both 430 Buck Jones Road parcel and the U-Haul parcel (436 Buck Jones Road) are under common ownership. Only the 430 Buck Jones Road parcel will be included in the rezoning application.

Question: Does the owner plan to change the existing building façade?

<u>Answer</u>: There could be minor changes to the façade, but the primary renovation concerns the filling stations and canopy. The parking lot would be resurfaced also.

<u>Question</u>: Will Little Sue Mini Mart replace the underground gas tanks? <u>Answer</u>: Yes, Little Sue Mini Mart will replace the underground tanks during its renovation.

<u>Question</u>: Will Little Sue Mini Mart perform an environmental study? <u>Answer</u>. When the underground tanks are replaced, the surrounding soils will be tested. Our team can provide additional information on this process.
