Conditions dated: September 28, 2022

- 1. Parking shall be prohibited between Bland Road and any building located within 20 feet of Bland Road.
- 2. Any building located within 20 feet of Bland Road shall have a building entrance facing Bland Road.
- 3. At least 50% of the Bland Road frontage shall be occupied by one or more buildings, the facade(s) of which shall be located not more than 20 feet from Bland Road. This requirement shall be considered a 'build-to' requirement for purposes of Section 1.5.6.C, and all provisions of that section shall be applicable to this requirement.
- 4. No more than two bays of parking shall be permitted between Wake Forest Road and any building located within 100 feet of Wake Forest Road.
- 5. Any building located within 100 feet of Wake Forest Road shall have a building entrance facing Wake Forest Road.
- 6. At least 50% of the Wake Forest Road frontage shall be occupied by one or more buildings, the façade(s) of which shall be located not more than 100 feet from Wake Forest Road. This requirement shall be considered a 'build-to' requirement for purposes of Section 1.5.6.C, and all provisions of that section shall be applicable to this requirement.
- 7. No structure shall exceed three stories in height within 150 feet of the boundary of any adjoining property listed in Attachment A.
- 8. The property owner(s) shall provide tenants with 180 days' written notice before the termination of their leases due to redevelopment of the property, so long as said leases are in full force and effect and not in default. The applicant shall provide a letter to the City Clerk's Office confirming that the required notice has occurred.
