RALEIGH TEEN CONNECT ACCESS GUIDELINES

1. Upon completion of registration form, a **Raleigh Teen Connect member tag** will be issued.
2. **Raleigh Teen Connect members will bring their membership tag daily** to access RTC programs, amenities, and events.
3. **Raleigh Teen Connect members can enter and exit offerings at their discretion**, however, leaving the programming space is signing out. Raleigh Teen Connect is not responsible for teens that have signed out.

RALEIGH TEEN CONNECT BEHAVIOR GUIDELINES

1. **Raleigh Teen Connect members will show respect** for each other and staff while in the program.
2. **Raleigh Teen Connect members will care for and respect all equipment and property.** Theft and vandalism are prohibited. City of Raleigh staff and programs will not be responsible for lost or stolen items.
3. **Raleigh Teen Connect members will not bring alcohol, drugs, or drug paraphernalia into the program.** Consumption and/or distribution is prohibited.
4. **Weapons of any kind are not permitted in Raleigh Teen Connect programs.** This includes but is not limited to guns, knives, tools, bats, razor blades, or any other devices that may be used as a weapon.
5. **Raleigh Teen Connect members will not engage in fights, verbal abuse, inappropriate language, or vulgar gestures.** Bullying, intimidation, and harassment are not allowed.
6. **Appropriate clothing is to be worn while in Raleigh Teen Connect programs** and while attending an off-site activity.
7. **Raleigh Teen Connect programs, amenities, and events are neutral territory with inclusive and designated safe zones.**

Non-compliance with Raleigh Teen Connect Guidelines is subject to the following actions by staff. Certain actions may result in immediate suspension or expulsion regarding federal, state, or local laws.

1st Incident: A warning will be issued in the form of a verbal reprimand.

2nd Incident: Behavior will be documented, and parent/guardian will be notified. Participant may be dismissed.

3rd Incident: Behavior will be documented, and parent/guardian will be notified. Suspension or expulsion from the program and facility may be applicable.
