Be Counted in the 2020 Census

How can you be counted?

Every household will receive an invitation from the U.S. Census Bureau to respond to the 2020 Census questionnaire in mid-March. When you receive it, you can respond online, by phone or by mail by the deadline stated.

What is the 2020 Census?

The U.S. Constitution requires our nation to count its population every 10 years. Every resident in all 50 states, the District of Columbia and the U.S. territories of Puerto Rico, American Samoa, the Commonwealth of the Northern Mariana Islands, Guam and the U.S. Virgin Islands will be counted in 2020. This year's census will include about 330 million people living in more than 140 million households.

Why does it matter?

Census data is used by government, nonprofit, corporate and community organizations to make important decisions that affect you, your family and your community. Below are a few ways that census information is used. For more details about how the census impacts your community, go to 2020census.gov/community-impact.

- Fair congressional representation in the U.S. House of Representatives and redistricting for state legislatures.
- Allocation of \$675 billion in federal funds to states and communities for public services, such as Medicaid, Head Start, mental health services, victim assistance services, SNAP-Supplemental Nutrition Assistance Program, school lunches and prevention of child abuse.
- Environmental impact assessments.
- Adequate utility resources and infrastructure that is ready to meet communities' needs.
- Critical needs such as roads and highways, hospitals and health clinics, schools and first responders (paramedics, police and firefighters).
- Emergency response information—how many people are in an area and where are they located.
- Pell Grants for tuition assistance.
- Identification of communities with specific public service needs for families, older adults' children and others.
- Business decisions about where to open new locations, create jobs and invest in communities.
- Job training programs.
- Real estate development for building new homes and revitalizing older neighborhoods.

Is my information protected?

Yes. In accordance with Title 13 of the U.S. Code, the Census Bureau has a legal obligation to protect your information and to keep it strictly confidential. Your answers can only be used to produce statistics. The law prohibits the Census Bureau from releasing any identifiable information about you, your home, your business or anyone who lives with you—not even to law enforcement agencies. Your private data is protected and your responses to the census questionnaire cannot be used against you by any court or government agency. 2020 Census Jobs Available




KIDS' CORNER
