

# Recycling and Yard Waste Collection Calendar 2023-2024

## Schedule B

(Schedule designation is based on service address)

### RECYCLING

Your recycling will be picked up every other week, on the same day as your garbage.

### YARD WASTE

Your yard waste will be picked up every other week, on the opposite week of your recycling, on the same day as your garbage.

### HOLIDAYS

Black shading shows City holidays that fall during your collection weeks. During holiday weeks, collection will be delayed one day. This applies if your collection day is on or after the holiday.



### PLEASE REMEMBER:

- **No Plastic Bags** inside recycling or yard waste carts.
- Cart lid cannot be open more than 12 inches.
- Carts at the curb by 6 a.m. on pickup day; carts removed from curb by 7 p.m. on day after pickup.
- We will not collect contaminated carts. Contaminated carts will only be serviced once the contents are sorted correctly.

## RECYCLING

- **No plastic bags!** Place loose recyclables in a City-issued blue cart.
- Remove all materials and flatten cardboard boxes before placing them inside the cart.
- **Do not** mix trash or yard waste with recyclables.
- **Do not** place recyclables outside cart.

## YARD WASTE

- **No plastic bags!** Only biodegradable paper bags.
- Place yard waste inside:
  1. City-issued 95-gal lime green cart
  2. Biodegradable paper bags (limit 15)
  3. Tied bundles (limit 5)
- Yard waste paper bags should be no more than 25 pounds. Bundles should be no more than 50 pounds.
