

#### Greetings,

It is my pleasure to present the Minority and Women Owned-Business Enterprise (MWBE) Program Annual Report for Fiscal Year 2022-2023.

The Minority and Women-Owned Business Enterprise (MWBE) Program advocates on behalf of historically underutilized businesses to promote diversity and inclusion in City of Raleigh contracting.

The City of Raleigh's Minority and Women-Owned Business Enterprise (MWBE) Program aims to connect underrepresented businesses with opportunities, resources, and technical assistance.

Some program accomplishments throughout the fiscal year include:

- Completed the City's first disparity study and established an implementation timeline and working committees for execution
- Established new partnerships with various business resource organizations
- Led two strategic plan initiatives that increased program awareness and business resource development
- Complied with the State of North Carolina's minority business participation reporting requirements (HUBSCO) on building projects for all 4 quarters and exceeded the State's 10% goal
- As a part of our expanded community engagement efforts, launched inaugural Meet the General Contractor and Minority Enterprise Development (MED) Week Celebration events

The following report describes the City of Raleigh's efforts to ensure minority and women-owned businesses have greater access to public contracting opportunities, and summarizes program activity, prime contract, and subcontract utilization data for certified minority and women-owned businesses.

## **Looking Back at FY22-23**

#### **MWBE Work Group Meetings**

This internal work group consists of staff across various City of Raleigh departments. The work group focuses on collecting data in a standardized manner, simplifying current processes, and implementing new processes.



#### **Construction Bid Meetings**

MWBE Program staff maintains positive working relationships with all City departments and work collectively to promote the program at pre-bid, bid opening, and pre-construction meetings. These meetings were held both virtually and in-person.



#### **Department Engagement**

MWBE Program staff expanded working relationships within various City departments including Housing & Neighborhoods, Transportation, Fire, Police, Raleigh Convention & Performing Arts Complex, Raleigh Water, Parks & Recreation, Engineering Services, and Solid Waste Services.

#### **Outreach & Community Engagement**

During the year, the MWBE Program staff actively engaged the MWBE business community through outreach events, educational workshops, statewide and local conferences, referrals, and one-on-one counseling sessions.

MWBE Program staff members served on boards, volunteered with committees, and engaged with community organizations to add a business perspective on diversity and inclusion. Some of the organizations with whom we engaged this year include:

The MWBE staff participated in multiple external outreach and community engagement events in FY22-23.

#### **VIVA MI RALEIGH**

In November 2022, MWBE staff hosted an information table at the Viva Mi Raleigh event. Hosted by the Department of Equity and Inclusion along with Housing and Neighborhoods, Parks & Recreation and Community Engagement, this event celebrated Hispanic-Latin culture and provided informative resources.

#### Sowing Unity Among Self-Sufficient Women Conference 2023

In March 2023, MWBE partnered with the Hispanic-Latino Ecosystem partners (General Consulate of Mexico, General Consulate of Guatemala, Small Business Administration, The Women's Business Center of NC, DurhamTech, InStepp Inc., and Mil Mujeres) to lead a panel discussion where women learned about business, employment, immigration, and personal growth. This event celebrated Hispanic-Latinas and connected them with unique resources inside North Carolina—a one-stop event to promote economic development, career development, and social advancement.

## **External Engagement**





#### Meet the General Contractors Workshop

In May 2023, staff kicked off the first in a series of workshops that allow MWBEs to meet and network face-to-face with general contractors. The event featured a successful general contractor who shared their business expertise, engagement tips, and success stories with the MWBE community. Interested vendors also learned about the general contractor's subcontractor solicitation and pre-qualification process for the City.

#### Raleigh Neighborhood Exchange

The Raleigh Neighborhood Exchange (RNEX) is an annual event hosted in September 2022 by the Neighborhood Enrichment Division in honor of Neighborhoods Month. MWBE staff attended this event to provide information regarding the MWBE Program and resources to gain knowledge on how to participate on city projects, how to become certified as minority business with external partners such as NCDOA HUB office and NCDOT DBE office and its benefits.



## **Education**



#### **HUB/DBE Certification Information Sessions**

In collaboration with the NC Department of Administration and the NC Department of Transportation, MWBE Program staff facilitated free public quarterly information sessions to educate businesses on NC Department of Transportation Disadvantaged Business Enterprise (DBE) and NC Office of Historically Underutilized Businesses (HUB) Certifications.

Our partners presented the benefits and processes of their respective certification programs, while the MWBE team concentrated on City of Raleigh's MWBE program elements and how to become registered suppliers with the City. Additionally, information was shared on how all partners work collaboratively to advocate for certification and minority business success.



For FY22-23,

4 Certification Information Sessions were conducted with 25–30 minority business owners attending each session.

#### **Annual Business Expo**

The 24th Annual Raleigh Small Business Expo was held on March 16, 2023, in partnership with the City of Raleigh's MWBE Program and the Wake County Public School System. The event featured 63 public and private industry companies, as well as various City of Raleigh and Wake County Public School System Departments. Over 245 attendees participated in workshop sessions and networking opportunities. As a special feature of recognition, both the City of Raleigh's MWBE Program and the Wake County Public School System presented awards to their MWBE Contractors of the Year.




## Raleigh Water: State Street Water & Sewer Improvements Phase 2




#### Raleigh Water: Twin 72-Inch Diameter SS

#### **DATA COLLECTION**

The City of Raleigh's MWBE Program team employs various data collection methods to identify trends in MWBE utilization and program effectiveness. The MWBE Program team also uses operational analysis to improve programming and to identify needed resources to support MWBE successes.

To further inform best practices in serving the MWBE community, data collected through the City's 2nd Annual Small Business, Start-up, and Minority-Owned Business Survey was used to identify areas for improvement, which helped the team to plan more strategically and intentional in connecting businesses to opportunities, and bridge gaps in utilization.

Table 1 illustrates some of the operational data that the MWBE team has collected over the past 3 fiscal years, highlighting construction contracting of \$300,000 and above.

Considering projects of \$300,000 or more, 35 projects, totaling \$168,394,099.06 were monitored and reviewed for FY 22-23. The total amount spent using Minority and Women-Owned Business Enterprises totaled \$36,642,894.97, exceeding the previous fiscal spend by 4.29%, and the City of Raleigh's 15% aspirational goal by nearly 7%.
